Services the unit offer include therapeutic drug monitoring evaluation and monitoring of workplace environments, biological monitoring of solvent exposure and drug screening.

CHL can test for a wide range of illicit drugs. Routine screening can includes testing for:

- Amphetamine type substances
- Benzodiazepines
- Cannabinoids
- Cocaine metabolites
- Opiates
- Synthetic Cannabinoids



All workplace drug testing conducted by CHL follow **AS/NZS 4308:2008 or AS/NZS 4760:2019 standard testing procedures**. Following these standards ensures the collection and testing procedures are accurate and able to withstand legal challenge if required.

CHL's workplace drug testing is **UNIQUE** in its ability to use state of the art equipment to test for individual drugs rather than the drug classes (I.e. CHL can say a drug is Ecstasy, rather than just listing the substance as an amphetamine type substance). This can help ensure prescription drugs are not confused with illegal drugs if in the same testing group. It also takes away the possibility of cross reactivity and the associated uncertainty. CHL is also able to detect substances taken within the past 2–3 days, as well as conduct confirmatory testing if necessary without requiring an additional sample from the employee.

A negative screening test for urine samples requires no further testing. If the test is non-negative for an illegal substance, then the specimen will be sent for extra testing, to confirm the initial result – this is a **LEGAL** requirement.

CHL will then report back to the employer, who will have a plan around the management of a positive result as part of their workplace drug policy.
